### **ENGAGEMENT OF GRADUATE PROJECT ENGINEER AND DIPLOMA PROJECT ENGINEER ON TENURE BASIS**

Offline applications are invited for Engagement of Graduate / Diploma Engineers as Tenure based Graduate / Diploma Project Engineers in Chemical & Mechanical trades who are possessing Apprenticeship in manufacturing / handling of military ammunition, explosives, and hazardous chemicals. Persons with required qualification, experience and trained in Ordnance Factories under MIL or factories manufacturing ammunition / explosives and possess above skills are to be engaged on Tenure based hiring as Project Engineer to work in Ordnance Factory Chanda, Maharashtra. The personnel should be able to start the job from day one with very limited or no learning curve in the field of safety, ammunition handling and quality required for ammunition and explosives production. Their engagement shall be on contract basis initially for a period of 01 (One) Year which may be extended for another period of three years i.e. total maximum period of 04 (four) years with renewal on yearly basis from the date of engagement (including initial period) based on factory requirement and individual's performance.

- (4) **Age Limit: (\*)** The maximum age limit applicable to General Category of candidates is 30 years. The same will be reckoned as on **04/02/2026**. In case of Ex-Apprentices, if the age bar comes in the way, the same would be relaxed to the extent of the period for which the Apprentice had undergone the training. Age relaxation as admissible will be given to SC/ST/OBC-NCL/PwBD/Ex-serviceman candidates is as under:

- (7) **Closing Date for Receipt of Application: (\*)** 21 days from the date of publication of Advertisement / corrigendum (whichever is later).

(8)(i) **Criteria for Engagement:** - Engagement shall be for a period ranging from one to four years as mentioned above in Para (1). The tenure will come to an end automatically on completion of four years' period from the date of joining, without any further notice. **The employment can be terminated, at any time, during the period of tenure engagement, by giving one month's notice by either party or payment of the Basic Pay + IDA component in lieu of the Notice. There will not be any commitment to the candidate either for absorption as permanent employee or extension of term.**

(ii) Such Personnel would generally be engaged to undertake specific jobs/projects/programmes/tasks in Core Technical areas like Design, Manufacturing/Maintenance/Quality Control, Production Engineering, Management Services etc. However, if requirement arises in any other area which cannot be met by other means, personnel can be engaged in such areas also.

(9) **Remuneration:**

- i. Tenure Based Personnel to be paid at the rate of 1/30<sup>th</sup> of the pay at the basic pay plus dearness allowance for work of 8 hours a day.
- ii. IDA as prevalent will be applicable.
- iii. House Rent Allowance as per classification of cities (When Company Quarter is not Available)  
**Note:** In case of availability of company Quarters, priority should be given for allotment of quarters.
- iv. The performance of the individual on fixed term employment will be evaluated on the format as given at Annexure-II. Individuals having performance rating poor or below will be given One months' time in writing to improve their performance. After one months' again performance will be evaluated and if again the performance rating found poor or below, the services of the individual will be terminated by given 15 days' notice.
- v. Personnel engaged will be eligible for EPF and employee Compensation act as per government guidelines.
- vi. Personnel engaged on fixed term basis are eligible to bonus (If applicable) as per Bonus Act 1965 amended time to time.

**(10) Mode of Selection/Process of Engagement:**

- i. Selection of the candidates shall be done based on the Marks scored in the Degree and diploma and Personal Interaction/Interview only, in the order of merit. Separate merit list will be made for degree & Diploma Project Engineer respectively. (Note: Written test will not be conducted)
- ii. Factories/Units Offices can decide the cut off percentage for calling candidates for Personal Interaction/Interview, based on the Marks secured in the Qualifying Examination i. e. Graduation and Diploma prescribed for a particular Trade/Discipline, to ensure sufficient competition.
- iii. Merit list will be prepared based on combine marks secured in Degree/Diploma and Personal Interaction/Interview.
- iv. Weightage of marks in Degree/Diploma and Personal Interaction/Interview will be 85% and 15% respectively.
- v. Candidates scoring marks more than cut-off marks in Degree/Diploma and Personal Interaction/Interview will be called for Document Verification in the order of Merit. The number of candidates called for Document Verification will be limited to the number of posts notified (Discipline/Category wise).
- vi. In case of rejection of candidates during the Document Verification process on account of non-availability of requisite documents/testimonials, not meeting the advertised criteria with respect to Age, Qualification, Experience, etc. next candidate will be called for Document Verification in the order of Merit (Discipline/Category wise). The number of next candidates called for Document Verification will be limited to the number of candidates rejected.
